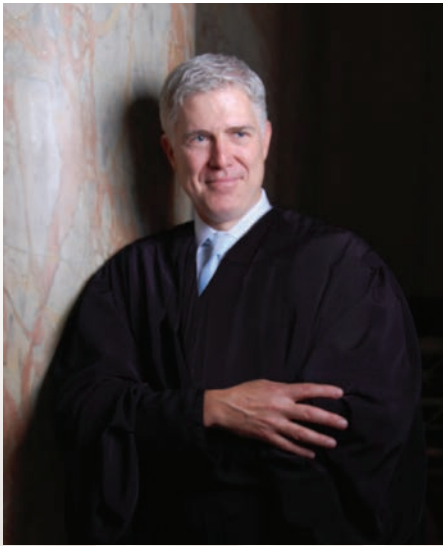

U.S. SUPREME COURT JUSTICE NEIL GORSUCH TO BE THE GUEST OF HONOR AND ACCEPT "BOOK OF THE YEAR IN LAW" AWARD



At the Awards program this year U.S. Justice Court Justice Neil Gorsuch will be honored for his book *A Republic, if You Can Keep It*. We are honored that Justice Gorsuch will attend and be interviewed on the best seller book.

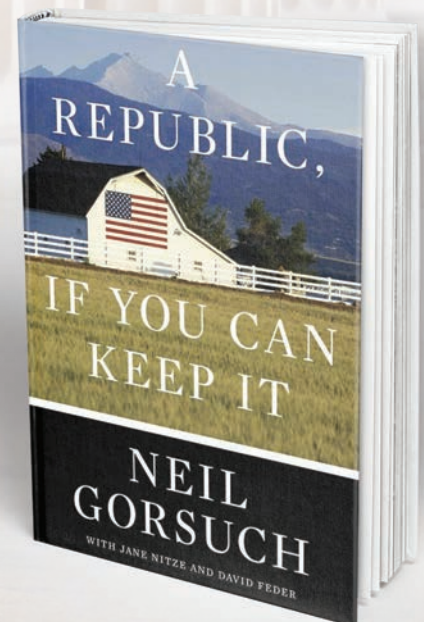
Judge Ed Forstenzer, former judge of the Mono County Superior Court, who is a mainstay of the awards program, analyzed the book as Chair of the Book of the Year in Law Committee. Bill Ryan, the former chair of the White House Plain Language Committee and Bill Burton

also serve on the committee. After reading the book, Judge Forstenzer opined, "Justice Gorsuch explains in great detail his judicial philosophy and the influence that Justice Scalia had on it. He presents his perspective on the constitutional balance necessary to maintain our republic. His book is well written and full of interesting stories."

Mr. Burton added "We are delighted and honored that the Justice will attend and be our Guest of Honor. The 21st awards program is sure to be truly spectacular."

Justice Gorsuch was nominated by President Donald Trump to succeed Antonin Scalia and took the oath of office on April 10, 2017. He earned a Bachelor of Arts from Columbia University, a Juris Doctor from Harvard University, a Doctor of Philosophy in Law from the University of Oxford. From 1995-2005, Justice Gorsuch was in private practice with the law firm Kellogg, Huber, Hansen, Todd, Evans & Figel. Justice Gorsuch was Principal Deputy Associate Attorney General at the U.S. Department of Justice from 2005 until

his appointment on the Tenth Circuit. Gorsuch was nominated to the United States Court of Appeals for the Tenth Circuit by President George W. Bush on May 10, 2006. He clerked for Judge David B. Sentelle of the U.S. Court of Appeals for the D.C. Circuit from 1991-1992 and U.S. Supreme Court Justices Byron White and Anthony Kennedy from 1993-1994. He is the first Supreme Court Justice to serve alongside another Justice for whom he once had clerked.



SUPERSTAR SARA BAREILLES TO PERFORM AT 2020 BURTON AWARDS



We are delighted to have singer-songwriter, actor, and author Sara Bareilles headline the 2020 Burton Awards performance.

Ms. Bareilles first achieved mainstream critical praise in 2007 with her widely successful hit “Love Song,”

which reached No. 1 in 22 countries around the world from her debut album *Little Voice*. Since then, she has gone on to receive seven Grammy® nominations throughout her career, which include Song of the Year and Best Female Pop Vocal Performance for “Love Song” and one Album of the Year for her highly acclaimed third studio album, *The Blessed Unrest*. Her book, *Sounds Like Me: My Life (So Far)* in Song, was released in the fall of 2015 by Simon & Schuster and is a New York Times best seller. Making her Broadway debut Ms. Bareilles composed the music and lyrics for *Waitress*, for which she received her first Tony® Award nomination for Best Score and a 2017 Grammy® Award nomination for Best Musical Theater Album. She also made her Broadway acting debut in 2017 by stepping into the lead role in *Waitress*.

2018 was a big year for Ms. Bareilles, she co-hosted the Tony Awards®, was nominated for an Emmy® and was awarded with the Songwriters Hall of Fame’s Hal David Starlight Award. She also teamed up with Apple as an executive producer for *Little Voice* a 10-episode series, which she will create the original music for. What’s Inside: Songs from *Waitress*, her most recent solo studio album, is out on Epic Records.

In April 2019, Ms. Bareilles released her fifth full-length and first album of original material since 2013, entitled *Amidst The Chaos*. For this latest body of work, she joined forces in the studio with legendary Academy® Award-winning producer T Bone Burnett. As a result, the album spotlights her voice as a singer and storyteller like never before, while making an enduring statement.

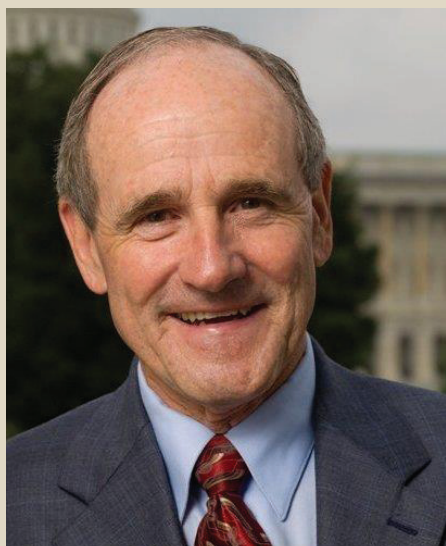
mentalism and mind-reading create an interactive experience that redefines the very nature of a magic show... one that truly needs to be seen to be believed.

Dorian Daley, Executive Vice President and General Counsel at Oracle Corporation, 2019 Legends in Law Winner

She is a 1986 graduate of the Santa Clara University School of Law and a 1981 graduate of Stanford University. R. Hewitt Pate, Vice President and General Counsel at Chevron Corporation, 2018 Legends in Law Winner

R. Hewitt Pate, is Vice President and General Counsel for Chevron Corporation, a position he has held since 2009. As Chevron's chief legal officer, Pate directs the company's worldwide legal affairs and serves on the company's Executive Committee.

Pate, a long-time partner at Hunton & Williams in Washington, D.C., headed the firm's Global Competition practice prior to joining Chevron. From 2003 to 2005, Pate served as the assistant attorney general for the Antitrust Division of the U.S. Department of Justice. He was a deputy assistant attorney general in the Antitrust Division, responsible for energy, transportation and other

regulatory matters, from 2001 to 2003. In 1999, Pate served as Ewald Distinguished Visiting Professor of Law at the University of Virginia.

Earlier in his career, Pate was a law clerk for U.S. Supreme Court Justice Anthony M. Kennedy, for retired Supreme Court Justice Lewis F. Powell Jr. and for Fourth Circuit Court of Appeals Judge J. Harvie Wilkinson III.

He is a member of the Washington, D.C., and Virginia bars, the American Law Institute, and the Council on Foreign Relations.

Pate joined Chevron in 2009 in the position he currently holds. He earned a bachelor's degree in history and English from the University of North



Carolina in 1984 and a Juris Doctor degree from the University of Virginia in 1987.

Tye G. Darland, Senior Vice President, General Counsel and Secretary at Georgia-Pacific LLC, 2018 Legends in Law Winner and Former Honorary Dinner Chair



Tye started his legal career as an associate attorney with Stinson, Morrison & Hecker in Kansas City, Missouri now known as Stinson Leonard Street. He joined Koch Industries, Inc. in Wichita, Kansas in June 1993 as an attorney. During his tenure at Koch, Tye was appointed

to various positions including Senior Counsel, Assistant General Counsel, Associate General Counsel, and General Counsel-Corporate/Commercial. He also held various officer positions at Koch, which have included Assistant Secretary, Secretary, and Vice President.

Tye is a member of the Board of

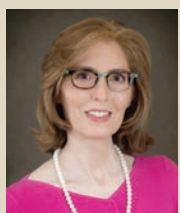

ST. REGIS IS THE NEW HOTEL FOR JUDGES AND WINNERS IN 2020

For the year 2020 only, the St. Regis in Washington, D.C. will be the flagship hotel for the Burton Awards Program. The Mandarin Oriental will be the prime hotel in subsequent years. It has long been a gathering place for both the capital's elite and visiting luminaries. Amelia Earhart was one of its first famous guests, and with its enviable location just two blocks north of the White House, it has since played host to everyone from presidents, including Truman, Kennedy, and Reagan, to celebrities such as Jackie Onassis, Audrey Hepburn, and Elizabeth Taylor. Howard Hughes kept a permanent suite inside the elegant hotel during WWII.

Mr. Burton said "I have long-hoped our guests could someday be accommodated at the St. Regis. This is the year. We were able to make it possible after years of negotiations. Everyone should enjoy the smaller feel of staying at this fine property."

Next year, the event date will go back to May 19th, 2 weeks before Memorial Day weekend, since the Historical Society is always the first week of June at the Library of Congress and Supreme Court Justices submit their closing arguments on June 15th. The hotel will be the Mandarin Oriental.



IN MEMORIAM: JUSTICE JOHN PAUL STEVENS



We express our deepest sense of sorrow over the loss of US Supreme Court Justice John Paul Stevens. It was a great honor having him attend our event.

Justice Stevens was one of the longest-serving justices on the U.S. Supreme Court. He was on the court for 35 years, from 1975 to 2010. He retired at the age of 90. We send Janice Harley his longtime assistant Janice Harley our condolences.

Justice Stevens was born in Chicago, Illinois on April 20, 1920. He married Maryan Mulholland, and has four children. He received an B.A. from the University of Chicago, and a J.D. from Northwestern University School of Law. He served in the United States Navy from 1942-1945, and was a law clerk to Supreme Court Justice Wiley Rutledge during the 1947 term. He was admitted to law practice in Illinois in 1949. He was Associate

Counsel to the Subcommittee on the Study of Monopoly Power of the Judiciary Committee of the U.S. House of Representatives from 1951-1952, and a member of the Attorney General's National Committee to Study Antitrust Law in 1953-1955. He was Second Vice President of the Chicago Bar Association in 1970. From 1970-1975, he served as a judge on the United States Court of Appeals for the Seventh Circuit. President Ford

nominated him as an Associate Justice of the Supreme Court, and he took his seat December 19, 1975.



Justice Stevens was honored at our awards program for his book *Five Chiefs: A Supreme Court Memoir*. As Mr. Burton put it: "He was a giant on the High Court, a sensitive leader who possessed the greatest integrity and wisdom."

IN MEMORIAM: RALPH BRILL

Ralph Brill, dear friend to so many of us and longtime supporter of the Burton Awards, passed away this past July. He was a well-known professor at Chicago-Kent College of Law at the Illinois Institute of Technology for some 50 years, developing a legal writing program that became a national model for teaching concise, clear writing and the research behind it. He was the winner of the 2006 Burton Award for Outstanding Contributions to Legal Writing Education.

William Burton said, "He was a giant of a man as a person in legal writing, and he will be sorely missed. Ralph was warm, genuine and highly intelligent. He loved his family, including his dear wife, Karin. Ralph left behind a rich legacy in legal writing, and, at the same time, he will always be remembered for his love of others. Ralph was one in a million."



BILL PRESS LAUNCHES NEW PODCAST!

Bill Press, Master of Ceremonies for the Burton Awards, ended his daily, nationally-syndicated radio show on June 1, 2019, after 14 years to launch a new podcast. Mr. Press launched his podcast in June. Episodes are available on Apple and Google Podcasts. Mr. Press will also once again bring his charm and wit to the program as the Master of Ceremonies at the Library of Congress for the much-anticipated 2020 Burton Awards event. It will mark his 12th year in the role.

Mr. Press has enjoyed a high-profile career in government, politics, and broadcasting. He was chairman of the California Democratic Party from 1993 to 1996. He served as Chief of Staff to California State Senator

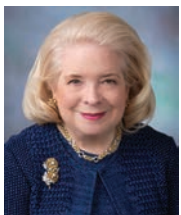

He began his career as a political commentator on KABC-TV from 1980 to 1989, and later on KCOP-TV, both in Los Angeles. He hosted Bill Press: True American on KFI-AM, Southern California's number one AM radio station, and was a regular weekend talk show host on KFI-AM from



1991 to 1996. Mr. Press has received numerous media awards for this work, including four Emmys and a Golden Mike Award. He was named Best Commentator of the Year by the Associated Press in 1992.
