### AWARDS PROGRAM TO FEATURE A TRIBUTE TO RETIRED U.S. SUPREME COURT JUSTICE STEPHEN BREYER



Justice Stephen Breyer, retired, will be honored for his contributions to the justice system and law at the 2023

Burton Awards.

Stephen Breyer served as Associate Justice of the Supreme Court of the United States from 1994-2022. He developed a reputation for pragmatism, optimism, and cooperation with both political parties. He was sworn in on August 3, 1994, after being nominated by President Clinton. He had previously been appointed by President Carter to the United States Court of Appeals for the First Circuit, where he later rose to the position of Chief Judge. He has also held positions as Chief Counsel of the Senate Judiciary Committee, Assistant Watergate Special Prosecutor, Justice Department attorney (antitrust section), and Supreme Court law clerk for Justice Arthur Goldberg. He also spent several years as a professor of law at the Kennedy School of Government and Harvard Law School.

Justice Breyer has written books and articles about administrative law, economic regulation, and constitutional law. He is a prolifiic writer; his long list of books includes: Regulation and Its Reform, Breaking the Vicious Circle: Toward Effective Risk Regulation, Active Liberty: Interpreting Our Democratic Constitution, The Court and the World: American Law and the New Global Realities, Against the Death Penalty, Breaking the Promise of Brown: The

Resegregation of America's Schools, and The Authority of the Court and the Peril of Politics, which was published in 2021. Justice Breyer received the "Book of the Year Award" for his well-recognized work, Making Our Democracy Work: A Judge's View.

We look forward to honoring the Justice at the event.

### THE 2023 BURTON AWARDS PROGRAM TO BE HELD AT THE NATIONAL PORTRAIT GALLERY AND SMITHSONIAN AMERICAN ART MUSEUM

# JONATHAN SKRMETTI, ATTORNEY GENERAL OF TENNESSEE, TO BE KEYNOTE SPEAKER AT LEGENDS IN LAW LUNCHEON



Our program was delighted when Attorney General Jonathan Skrmetti accepted our request to be the Legends in Law Luncheon

guest speaker. We thank our Luncheon Speakers Chair, Bernie Nash of Cozen O'Connor, for making the arrangements.

General Skrmetti was sworn in as Tennessee's 28th Attorney General in 2022. As Attorney General, he has focused on protecting Tennesseans from consumer fraud and deceptive business practices. Combating ongoing health issues has also been a top priority of his office; since becoming Attorney General, Skrmetti has reached settlements with Walmart regarding its contributions to the ongoing opioid epidemic, and with Juul Labs, Inc., the electronic cigarette manufacturer.

Previously, Skrmetti served as Chief Counsel to Tennessee Governor Bill Lee, from 2021 to 2022, and as Chief Deputy Attorney General to Tennessee Attorney General Herbert H. Slattery III, from 2018 to 2021. Prior to his work on behalf of the State of Tennessee, Skrmetti was a partner at Butler Snow LLP, and served as an Assistant U.S. Attorney with the Civil Rights Division of the U.S. Department of Justice, and as a federal prosecutor in Memphis. He also taught cyberlaw as an adjunct professor at the University of Memphis.

The event will be held at the Hay Adams Hotel, Top of the Hay.

### "FINEST ACADEMICIAN IN LAW" Awarded to Dean William M. Treanor of Georgetown University Law Center



The inaugural "Robert A. Katzmann Award for Academic Excellence" will be given to Dean William M. Treanor of Georgetown Law Center. The new award, inspired by the life and work of the Honorable Robert A. Katzmann, will be presented annually to a law school dean or professor who has "brought added prominence and recognition to their academic institution, and has demonstrated the finest leadership

in overseeing and directing staff operations, or the highest scholarship and dedication to students." The award is named after the esteemed Robert A. Katzmann who served from 1999 to 2013 on the U.S. Court of Appeals for the Second Circuit. From 2013 to 2020 he was Chief Judge.

Dean Treanor has served as Dean since 2010. While at Georgetown Law, Dean Treanor has sought to make the Law Center more accessible to some of the world's most promising law students. During his tenure, Georgetown has more than doubled financial aid and scholarship programs, launched the RISE program which provides academic support for students from historically underrepresented groups, and established the Early Outreach Initiative which brings the Law Center's dean of admissions, current law students, and alumni into urban high schools across the country to encourage student interest in pursuing careers as lawyers.

Dean Treanor has also focused on increasing opportunities for students to pursue careers in public interest law. During his tenure, Georgetown has initiated a program of post-graduate fellowships that have enabled more than 100 graduates to work in public interest jobs, and, in combination with the law firms ArentFox Schiff and DLA Piper, the Law School has launched the DC Affordable Law Firm, a "low bono" law firm where recent Georgetown Law graduates provide legal representation to people of limited means.

Before coming to Georgetown, Mr. Treanor was Dean at Fordham Law School. He also served in a variety of positions in the government, including Deputy Assistant Attorney General in the Office of Legal Counsel, U.S. Department of Justice; Associate Counsel, Office of Independent Counsel during the Iran/Contra investigation; Speechwriter to the United States Secretary of Education; Special Assistant U.S. Attorney in the District of Columbia United States Attorney's Office; and Special Assistant to the Chair of the New York State Commission on Government Integrity. He was law clerk to the Honorable James L. Oakes, U.S. Court of Appeals for the Second Circuit. Treanor has a Ph.D. in history from Harvard University, a J.D. from Yale Law School, and a B.A. from Yale College.

Justice Sonia Sotomayor will present the award to Dean Treanor at the event in June.

The World Justice Project focuses on advancing the rule of law worldwide through research, strategic convenings, and support for innovative programs. Ms. Andersen has more than 20 years of experience in the international

legal arena, having served previously as Director of the American Bar Association Rule of Law Initiative (ABA ROLI) and its Europe and Eurasia Division (previously known as the Central European and Eurasian Law Initiative or ABA CEELI), as Executive Director of the American Society of International Law, and as Executive Director of Human Rights Watch's Europe and Central Asia Division.

Ms. Andersen is an expert in international human rights law, international criminal law, and transitional justice, and she has taught these subjects as an adjunct professor at the American University Washington College of Law. She is a member of the Council on Foreign Relations and serves as a member of the Board of Trustees of Williams

College as well as on the governing and advisory boards of several international non-profit organizations. She is the recipient of a number of awards for her work in the international rule of law field, including a Williams College Bicentennial Medal, the American Society of International Law Prominent Woman in International Law Award, and the Case Western University Law School Humanitarian Award.



### ELIZABETH PUGH CAPTURES PUBLIC SERVICE AWARD IN GOVERNMENT



The 2023 Public Service Award in Government at the Executive Level is presented to Elizabeth Pugh. Elizabeth

Pugh was the General Counsel for the Library of Congress for 22 years. She retired from federal service on December 31, 2022. Ms. Pugh is credited with engendering the more than 20-year relationship between the Library of Congress and the Burton Awards.

Over her decades of service, Ms. Pugh oversaw legal support for every aspect of the Library's operations. She has been a key advisor on the numerous reorganizations in the Library and all the stages of transformation to the digital library of the future. Ms. Pugh's personal career highlights at the Library are the Rosa Parks Collection acquisition, where she worked closely with donor Howard G. Buffett's personal attorney, and the acquisition of the Waldseemüller Map, which culminated in a ceremony where Angela Merkel personally transferred the map to the people of America.

During her time at the Library, she was instrumental in building collaborations with other federal agencies, including the creation of General Counsel groups for the Legislative Branch and federal cultural agency GCs, active participation in the federal General Counsel Exchange, and the establishment of a long-running series of FLICC-FEDLINK collaborative meetings between federal agency lawyers and librarians.

Mr. Burton said, "Elizabeth Pugh has been a close friend of our program. She is a visionary, and I can never thank her enough for suggesting a close and everlasting relationship with such a pre-eminent institution."

# THOMAS KRAUSE OF US PATENT AND TRADEMARK OFFICE TO BE AWARDED PUBLIC SERVICE IN GOVERNMENT AT THE MANAGEMENT LEVEL



The 2023 Public Service Award in Government at the Management Level will be presented to Thomas Krause.

Thomas Krause Deputy General Counsel, Intellectual Property Law, US Patent and Trademark Office.

In his current role as the Solicitor of the United States Patent and Trademark Office, (USPTO), Mr. Krause oversees all intellectual property-related litigation involving the USPTO, including both when the

USPTO appears as a party, and when it advises the government as to what positions to take as amicus curiae in intellectual property cases.

Throughout his career, Mr. Krause has had many outstanding accomplishments; Mr. Krause himself has argued over 20 cases to the Court of Appeals for the Federal Circuit on behalf of the USPTO, prevailing in all but one of them. A notable recent argument was his February 2020 argument in *Hyatt v. Iancu*, a case that involved a novel application of the doctrine of prosecution laches, and whose result could save the agency many millions of dollars in

examination costs. He has also made significant contributions in developing the government's position in notable patent cases, including *Bilski v. Kappos*, 561 US 593 (2010), and *Kimble v. Marvel*, 135 Ct. 2401 (2015), in which the government argued successfully that the doctrine of stare decisis should hold sway in patent law.

Mr. Krause leads an office of 32 litigators, including 24 attorneys specializing patent litigation, 3 attorneys specializing in trademark litigators, and 5 attorneys specializing in attorney discipline litigation.

### COLONEL TODD W. PENNINGTON OF SPACE COMMAND TO BE PRESENTED THE 2023 MILITARY SERVICE AWARD



The Burton Awards is proud to announce that Colonel Todd W. Pennington, the Staff Judge Advocate for United States Space Command, will receive the 2023 Military Service Award. The award will be presented by Jane Sullivan Roberts, Chair of the Select Committee, which also

comprises of William Ryan, former Chair of the White House Plain Language Committee, and Larry Youngner, Colonel, USAF (Ret.), Of Counsel at Tully Rinckey. The background information was researched by members of the Law Library of Congress.

Colonel Todd W. Pennington is the Staff Judge Advocate for United States Space Command, the Unified Combatant Command responsible for conducting operations in, from, and to space to deter conflict, and if necessary, defeat aggression, deliver space combat power for the Joint/ Combined force, and defend U.S. vital interests with allies and partners. Colonel Pennington is a graduate of the Cecil C. Humphreys School of Law at the University of Memphis and entered active duty as an Air Force ROTC distinguished graduate in 1998. He is a veteran of

multiple combat zone deployments supporting joint special operations forces. Throughout his career, he has served in the Office of the Chairman of the Joint Chiefs of Staff as Deputy Legal Counsel, and as a Staff Judge Advocate at the Field Command, Numbered Air Force, Wing, and Joint Task Force levels in the United States, Europe, Japan, Africa, Iraq, and Afghanistan. Colonel Pennington was previously the Staff Judge Advocate for United States Space Force, and led the strategic transformation of the Space Force legal enterprise from one supporting single legacy Air Force Major Command to the Space Force's current force structure of three Field Commands. His military decorations include the Legion of Merit (second award) and the Bronze Star (third award).

Mr. Burton said, "I thank Jane Roberts for chairing the committee, and being so instrumental in selecting the winner. This year, the program adds an exciting new dimension. For the first time, we select a winner from the Space Force. The winner has far surpassed the strictest standards. We are honored to choose Colonel Todd W. Pennington because of his leadership and many successes."

### BERNIE NASH RECOGNIZED BY NY BROOKLYN LAW SCHOOL AS "ALUMNUS OF THE YEAR!"




Bernard Nash, Co-Chair of the State Attorneys General Practice at Cozen O'Connor, and Honorary Board Member and
