Thomas L. Sager is a former Senior Counsel at Ballard Spahr. He began his career with E.I. DuPont de Nemours

as an attorney in the Labor, Benefits & Corporate Security Group and spent more than a decade as chief litigation counsel before being named Senior Vice President and General Counsel in 2008. During his tenure, he oversaw significant litigation involving governmental investigations, product liability, environmental, toxic tort, labor and employment, securities, antitrust, and tax.

Mr. Sager was a strong and early proponent of diversity in the legal profession. He helped pioneer the DuPont Convergence and Law Firm Partnering Program, which redefined the way in which law firms measure success, encourage creativity and collaboration, increase efficiency, and retain and promote women and minorities.



Les Parrette is President of One Page Thinking, an innovative data visualization firm he founded. He is also

an independent director of Innospec Inc. He has enjoyed a distinguished 35-year career as a Big Law partner, chief legal officer of three global industrial companies, entrepreneur, and mentor to students and young professionals. Mr. Parrette was recognized as a "Legend in Law" in 2012. He is also a recipient of the Corporate Counsel Lifetime Achievement Award awarded by the Atlanta Business Chronicle (2021). Mr. Parrette holds a Bachelor of Arts degree and a Juris Doctorate in Law from Harvard University.

Yabo Lin is a partner at Sidley Austin LLP. He counsels both U.S. and international clients on corporate matters,

including mergers and acquisitions. His experience covers a wide range of industries, including information technology, e-commerce, fintech, biotech, and manufacturing.
