U.S. SUPREME COURT JUSTICE—STEPHEN G. BREYER—GIVEN FIRST EVER RETIREMENT TRIBUTE BY BURTON AWARDS

U.S. Supreme Court Justice, Stephen G. Breyer, (retired), was honored for his contributions to the justice system and the legal profession at the 2023 Burton Awards.

The tribute to Justice Breyer began with a video montage, from Justice Breyer's childhood up to his current role as Byrne Professor of Administrative Law and Process at Harvard Law School. The presentation was followed by personal reflections by Jennifer Newstead, Chief Legal Officer of Meta and former law clerk for Justice Breyer. The program was honored when Justice Ketanji Brown Jackson spoke and shared her experiences as a law clerk to Justice Breyer and expressed her appreciation for the wealth of knowledge she gained in this position, which she has applied as Justice Breyer's successor. Finally, our Master of Ceremonies, Bill Press, conducted a riveting interview with Justice Breyer.


25TH ANNIVERSARY BURTON AWARDS PROGRAM TO RETURN TO THE LIBRARY OF CONGRESS



THE 24TH ANNIVERSARY AWARDS PROGRAM – MOST SPECTACULAR AND SUCCESSFUL EVENT TO DATE

The 24th annual program was held on Monday, June 12, 2023, at the National Portrait Gallery and Smithsonian American Art Museum in Washington, D.C. From the overwhelming responses we received, the program was highly successful.

For the first time ever, the program included a tribute to the life and career of a retired U.S. Supreme Court Justice. U.S. Supreme Court Justice, Stephen Breyer, was honored by the awards program for his illustrious career on the nation's highest court. Chief Legal Officer of Meta, Jennifer Newstead, spoke about her personal experiences as Justice Breyer's law clerk. She shared how "Justice Breyer

ran his chambers with an unusual openness and intellectual generosity towards his law clerks. He encouraged us to debate with him and to tell him exactly what we thought. The Justice was inclusive, curious, and deeply engaged." Ms. Newstead further reflected, "It was an unforgettable experience, for which I have only become more grateful with each passing year." These remarks were followed by comments from U.S. Supreme Court Justice Ketanji Brown Jackson, Justice Breyer's successor. Justice Ketanji Brown Jackson said, "It is an honor to be here to say a few words about Justice Stephen Breyer who, as you may know, is my former boss, lifelong mentor, and personal









friend. My clerkship with Justice Breyer, in particular, was an extraordinary gift." The tribute culminated in a riveting interview with Justice Breyer, conducted by Bill Press, political commentator and longtime Burton Awards Master of Ceremonies. During the interview, Justice Breyer said, "I want to thank Bill Burton, Jennifer, Ketanji, the people and what they said. I am genuinely touched. I didn't know what the word tribute meant but given the people you chose here and given what they said, that was a tribute and I appreciate it a lot." Bill Press followed by saying, "Justice, they were speaking for every single one of us, so thank you."

The inaugural "Honorable Robert A. Katzmann Award for Academic Excellence" was presented to William M.



Treanor, Dean of Georgetown University Law Center. Although unable to join in person, Justice Sonia Sotomayor delivered heartfelt remarks via video reflecting on the significance of the award, appropriately named in honor of her treasured friend, the late Honorable Robert A. Katzmann. When Justice Sonia Sotomayor spoke about the former Chief Judge of the Second Circuit U.S. Court of Appeals, she referred to him as, "my dear friend and brother." She went on to say, "I am so happy that the first recipient of the Burton Awards Honorable Robert A. Katzmann Award for Academic Excellence is William M. Treanor. He embodies the spirit of the Katzmann Award and has the same heart of the legal lion that our friend Bob Katzmann possessed." This was followed by remarks from Gene Sperling, Senior Advisor to the President of the United States, who referred to Robert A. Katzmann as his, "other big brother for forty years." with Deborah Enix-Ross, Immediate Past President of the American Bar Association; Linda Klein, former President of the American Bar Association and Senior Managing Shareholder at Baker Donelson; and Elizabeth Andersen, Executive Director of the World Justice Project. Tom Sager was awarded the program's inaugural "Diversification in Law" award for his dedication to upholding and promoting diversity in the legal profession. The next recipient, Elizabeth Pugh, who recently retired as General Counsel at the Library of Congress, received the Public Service Award in Government at the Executive Level. It was noted that the relationship between the Burton Awards and the Library of Congress was engendered by Ms. Pugh who first encouraged the relationship with the awards program. The third award was presented to Thomas W. Krause, Solicitor for the United States Patent and Trademark Office. He was recognized with the award for Public Service in the Government at the Management Level.

The ever-distinguished H. Rodgin Cohen, Senior Chairman of Sullivan & Cromwell, presented the Law Firm Leadership Award to Presiding Partner of Cravath, Swaine & Moore, Faiza Saeed. He said, "Faiza has led Cravath to new heights through her judgment, wisdom, openness to change and integrity, while still maintaining one of the most outstanding practices of any lawyer."

HAROLD HONGJU KOH, NAMED RECIPIENT OF 2024 "HONORABLE ROBERT A. KATZMANN AWARD FOR ACADEMIC EXCELLENCE"



Harold Hongju Koh, former Dean of Yale Law School from 2004-2009 and esteemed professor, has been selected as the distinguished recipient of the Honorable Robert A. Katzmann Award for Academic Excellence. This prestigious award will be presented to

Professor Koh at the Library of Congress on May 20, 2024, in recognition of his exceptional contributions to legal education and leadership within academic institutions. It seeks to honor those who have significantly elevated the profile of their institutions, demonstrated outstanding leadership skills in administrative roles, or showcased remarkable scholarly achievements in teaching. The award committee is chaired by inaugural award winner, Dean William Treanor. Dean Treanor said, "Dean Koh's great career embodies a profound commitment to academic excellence and public service, and he is unfailingly concerned with the well-being of others. His life reflects the values that Judge Katzmann held dear, and he is a most worthy recipient of this extraordinary honor."

Professor Koh is Sterling Professor of International Law at Yale Law School. He returned to Yale Law School in 2013

after serving for nearly four years as the 22nd Legal Adviser of the U.S. Department of State. Professor Koh is one of the country's leading experts in public and private international law, national security law, and human rights. He has received seventeen honorary degrees and more than thirty awards for his human rights work, including awards from Columbia Law School and the American Bar Association for his lifetime achievements in international law. He has authored or co-authored eight books, published more than 200 articles, testified regularly before Congress, and litigated numerous cases involving international law issues in both U.S. and international tribunals. He is a Fellow of the American Philosophical Society and the American Academy of Arts and Sciences, an Honorary Fellow of Magdalen College, Oxford, and a member of the Council of the American Law Institute.

Professor Koh's selection is a testament to his commitment to legal education, his exemplary character, and the profound respect he has garnered from peers and colleagues in the field. His achievement in receiving the Honorable Robert A. Katzmann Award for Academic Excellence is a fitting acknowledgement of his remarkable contributions to the legal education community.

ATTORNEY GENERAL FORD OF NEVADA TO BE GUEST SPEAKER AT 2024 LEGENDS IN LAW LUNCHEON

Attorney General Aaron D. Ford of Nevada will speak at the special luncheon held on Monday, May 20th, 2024. Bernard Nash of Cozen O'Connor who serves as the Luncheon Chair, made the arrangements. Since assuming office on January 7, 2019, General Ford holds the distinction of being the first African American to hold statewide constitutional office in Nevada. Attorney General Ford's diverse career includes serving as a State Senator, Majority Leader, Minority Leader, and practicing law as a partner at

prestigious firms. Educationally accomplished, Attorney General Ford holds five degrees, including a law degree and a Ph.D. in Educational Administration from The Ohio State University.

As a State Senator, Attorney General Ford played a pivotal role in passing legislation mandating police officers to wear body cameras and advocated for a "Conviction Integrity Unit" to address wrongful convictions. As the state's chief law enforcement officer, his mission is to protect Nevada families, guided by the office motto, "Our Job

is Justice." His priority areas, termed the "Five Cs," include constitutional rights, criminal justice reform, consumer protection, client service, and community engagement.

Attorney General Ford actively engages with the community through town hall forums on crucial topics such as racial injustice, law enforcement policies, hate crimes, and identity theft. Under his leadership, the Bureau of Consumer Protection has recovered over \$85 million for Nevada consumers, demonstrating a commitment to combating fraud and scams.

THE INAUGURAL "HONORABLE ROBERT A. KATZMANN AWARD FOR ACADEMIC EXCELLENCE" AWARDED TO DEAN WILLIAM TREANOR OF GEORGETOWN UNIVERSITY LAW CENTER



States, also spoke in honor of Dean Treanor and his late friend, Robert A. Katzmann.

Finally, William Treanor, Dean of Georgetown University Law Center, delivered an acceptance speech full of gratitude for the profound impact of Robert Katzmann on his life and work.

The World Justice Project focuses on advancing the rule of law worldwide through research, strategic convenings, and support for innovative programs. Ms. Andersen has more than 20 years of experience in the international legal arena, having served previously as Director of the American Bar Association Rule of Law Initiative (ABA ROLI) and its Europe and Eurasia Division (previously known as the Central European and Eurasian Law Initiative or ABA CEELI), as Executive Director of the American Society of International Law, and as Executive Director of Human Rights Watch's Europe and Central Asia Division.

Ms. Anderson is an expert in international human rights law, international criminal law, and transitional justice, and she has taught these subjects as an adjunct professor at the American University Washington College of Law. She is a

LINDA KLEIN CONTINUES TO SHINE FOR DYNAMIC LEADERSHIP IN LAW!

As former president of the American Bar Association, Ms. Klein is an honorary member of our Board of Directors. Because of her strong leadership and foresight, Ms. Klein recently led a major study on ethics, which was recommended by the American Bar Association to be adopted by the Supreme Court. She is currently a

Senior Managing Shareholder at Baker, Donelson, Bearman, Caldwell & Berkowitz, PC.

The American Bar Association has published a thorough study to explore the important factors that have impacted the public's lack of confidence in the American judicial system. Concerns raised in the study include Supreme Court rulings that contradict well-known precedents, skepticism about the Senate's confirmation procedure, and the lack of a defined code of ethics for the Supreme Court.

To address these challenges, the Task Force on Law, Society, and the Judiciary of the American Bar Association has proposed a number of recommendations. A comprehensive code of conduct for the Supreme Court should be adopted and made public. The judicial confirmation procedure should be improved by placing emphasis on temperament and objectivity. Education about the judicial system should once again be incorporated into the curriculum taught in public schools.

The study highlights the necessity of quick action to regain the public's trust in the judicial system and points out that some reforms can be carried out by the courts independent of congressional involvement. The objective is to address the system's deeper issues and restore trust in its fundamental checks and balances.
